



Appropriately Ordering Higher-Level Imaging Based On Patient Need

14 Year-Old- Male Athlete With A Gibbous Deformity: A Case Study

CASE STUDY

Ordering higher-level imaging is an integral function in a chiropractic practice. Unfortunately many clinicians order inappropriate testing for the suspected musculoskeletal condition being evaluated or the testing is ordered in an inappropriate time frame. Higher level imaging is appropriate when the patient is either not responding to conservative care or there is a condition that may need to be evaluated based on worsening patient complaints and physical examination findings. For uncomplicated spinal pain with no red flags, higher level spinal imaging is not recommended. This case that is being presented has a special circumstance.

Patient Information

This patient is a 14-year-old football player with a relative prominent congenital gibbous deformity at L1 /L2. Deformities of this type occur to approximately 12 percent of the population. This patient had no spinal pain but both the patient's parents and school for which he is attempting to play for wanted him to be cleared to play football. This required a physical examination and, based on the deformity that was seen, imaging needed to be performed.


Examination


This patient is quite large for his age. He is 5'8" and is 230 pounds. Thoracic range of motion was slightly limited in rotation bilaterally with no pain elicited. His lumbar range of motion is full with no pain elicited. There was slight tenderness at the level of the Gibbous deformity. There was no muscle spasm or facet joint tenderness.

Adams' Position was negative, Soto-Hall was also negative as was Chest Expansion test. Kemp's Test was also negative. The patient was neurologically intact with normal deep tendon reflexes, no loss of sensation and full muscle strength for both the upper and lower extremities. Based on physical examination finding this patient seemed physically fit to participate in sporting activities such as football. We still had the issue of this gibbous deformity that needed to be visualized for stability. X-Rays of his thoraco-lumbar spine were warranted in this case.

This patient is quite large and muscular for his age. X-Ray imaging was sub-optimal to visualize this deformity. The deformity is between L1 and L2. There is a 51 degree angle to this deformity. Although this deformity looks stable, I was not comfortable clearing this patient to play football unless I was able to see this deformity from a better perspective. Because this deformity is boney in nature, an MRI would not be the best choice to visualize this. MRIs are better suited for soft tissue such as intervertebral disc visualization. The better choice to visualize this deformity in this circumstance would be a CT scan. Because this deformity is at the thoraco-lumbar junction and this patient is subject to trauma playing football, I elected to order a CT reconstruction scan.

A CT reconstruction scan is a mathematical process which generates tomographic images from X-Ray projection data acquired at many different angles around the patient. The upside to a CT reconstruction scan is a much greater image quality than a normal CT scan, but radiation to the patient is increased. Based on the facts of





Findings

As you can see by the images shown on the right, image quality is superior to a normal CT scan. We can visualize this deformity in a 360° plane. We see the patient in an A-P plane. As more images are taken, the view of the spine starts to rotate in a counter clockwise direction. When we get to figure 3, we are now in the lateral plane where we plainly see this deformity with clear stability at the site of the deformity. We continue visualizing the deformity as the scan continues taking more images rotating the spine. This is now the P-A plane. As you can see, you can now visualize the spinous processes (Fig. 4).

As you can see, this higher-level of imaging was the best choice to image this deformity which was critical because of the patient's age and the sport for which he was playing. Based on this imaging, we see that this deformity was stable and he should not be in any increased risk for injury.

Conclusion

In conclusion, we as clinicians should be able to properly determine what higher-level of imaging is appropriate based on patient presentation, physical examination findings, timing and any extenuating circumstances presented.

GCA Promoting Lien Law, Co-Pay Legislation in 2019

By all accounts, the Georgia Chiropractic Association has a busy 2019 legislative season ahead, as the association works to pass two bills to better serve patients across the state.

GCA board member and District 73 House Rep. Dr. Karen Mathiak is introducing lien legislation (H.B. 9), which will allow for a chiropractic practice to have a lien on a cause of action accruing to an injured person for the costs of care and treatment.

"This is the same lien right that hospitals, nursing homes, physician practices and traumatic burn care medical practices have," Mathiak explained. "It's a lien against such causes of action, and wouldn't be against an injured person or any other property or assets."

The lien also would not be evidence of a person's failure to pay a debt, Mathiak further clarified. GCA is working on an informative Q&A sheet to hand out to legislators and other health care professionals to explain the legislation.

"We'll be involving our grassroots committee on this one," said Legislative Committee Chair Dr. John Webster. "Boots on the ground are always important, but we want to especially be loud on this one. It's a great boon to have one of our own, Dr. Mathiak, paying the way for this legislation."

GCA also continues to purse Co-Pay Legislation, which never made it out of committee in 2017 and 2018. As it did not pass during the two-year cycle, the association is now seeking a new sponsor for this bill.

The original phrasing of the bill would prohibit insurers from "imposing a copayment, coinsurance, or office visit deductible amount greater than such charges imposed on a physician or an osteopath to an insured for services rendered by a physical therapist, an occupational therapist, or chiropractor."

"This legislation is important for patients, especially for those who may only be able to afford a limited copayment," Villines explained. "It's important to the chiropractic profession that we take care of our patients by offering a safe and effective alternative to opioids for pain management. This is another way we can protect them and their wallets."

GCA also continues to pursue copay legislation, which passed out of the Senate but never made it out of the House Insurance Committee in 2017 and 2018. This helps us to connect you with your legislators on important issues. You can join by calling the GCA headquarters at 770-723-1100.

GCA Signs Letter of Support for ACA Medicare Legislation

The Georgia Chiropractic Association Board of Directors voted to sign a letter showing support of legislation championed by the American Chiropractic Association to expand Medicare coverage of services provided by chiropractors within the scope of their license.

H.R. 7157, introduced in November 2018 by Rep. Erik Paulsen (R-Minn.) would allow Medicare beneficiaries to access the chiropractic profession's broad-based, non-drug approach to pain management. Access to drug-free pain management in Medicare as well as private health care plans has become increasingly important in the wake of the nationwide opioid crisis.

The bill adds no new services; it only allows access to those current Medicare benefits that chiropractors are licensed to provide.

"This new law would cover X-Rays, therapies, extremity treatment and exams in addition to adjustment of the spine," explained GCA President Dr. Clark Stull. "This gives our seniors and those with disabilities a safe and effective alternative to opioids.

"GCA is proud to show support for this bill," he added.



When It Comes to Growing Your Practice, Think Small... Not Big By Dr. Ray Foxworth

I have spent years talking to chiropractors across the country and one of the biggest dilemmas most of them share, myself included, is determining the clinic's fee schedule. We are torn between running a profitable business and giving our patients access to affordable health care – in many cases diminishing the value of our services and making us the target of unnecessary risk. If we're offering lower fees for cash than insurance, or discounts that are far beyond our cost of billing, or not charging for some services, it could trigger inducement violations. Many of the doctors I speak with have not evaluated or raised their fees in over five years. While we are all aware of changes to the economy, and increases in the cost of doing business, we often put ourselves in the position of working harder and longer hours to make the same, or less, money than we did in previous years. And all because we fear that any increase in fees will result in fewer patients getting the care they need in our office.

On July 12, the U.S. government released updated inflation numbers that showed annual increases ranging from 1.4 to 24.3 percent. Yet, as business owners and doctors, we can't bear the thought of raising our fees just a fraction after five years. In reality, there is a fixed cost for a patient visit in our offices. As business owners, we are setting ourselves up to lose money when we don't know what that cost is.

Reviewing your provider contracts is crucial to practice success. You must read your provider agreements and understand every stipulation that you are agreeing to with your signature. Far too often, doctors find out well after the fact that a procedure regularly performed in the practice isn't covered or is bundled under the terms of the contract. Additionally,

providers may choose to add a new service or product and find that their provider agreement allows for reimbursement at a level lower than the actual cost of providing that product or service.


So, once you gave gathered all the data, what's next? There are several websites (such as chirocode.com and fairhealth. org) that provide fee calculators. These can give you an idea of "usual, customary and reasonable" charges and are usually listed by CPT code and zip code. Pulling published fee schedules (such as Workers' Comp) also lets you know if you are billing above, or below, UCR charges for your area. Take a look at these resources to see where you are versus other providers in your area. If your fees are lower, are you undervaluing the services you provide and leaving revenue on the table? Having this information available will give you a good idea of the overall financial health of your practice.

When I gathered this information, and considered raising my fees, I experienced a sense of dread. I felt that any increase, big or small, would turn patients away from my practice. What I didn't realize was that small adjustments to my fees could have a big impact on the financial health of my practice without burdening my patients with rising healthcare costs. For example, I discovered that by increasing my fees \$5 per visit (less than the cost of a cup of coffee), my practice would generate an additional month's worth of revenue per year.

Practice growth starts with taking small steps in the right direction. You don't have to dramatically increase your fees to improve your practice value and raise the perceived value of your services.

Chiropractors Keep Eye on National Medicare Legislation

ACA Promotes the Introduction of H.R. 7157



Championed by the American Chiropractic Association, H.R. 7157, introduced on Nov. 16, 2018 by Rep. Erik Paulsen (R-Minn.) would allow Medicare beneficiaries to access the chiropractic profession's broad-based, non-drug

approach to pain management, which includes manual manipulation of the spine and extremities, joint mobilization, soft-tissue massage techniques, physiological therapies, exercise instruction and activity advice.

Access to non-drug approaches to pain management in Medicare as well as private health care plans has become increasingly important in the wake of the nationwide opioid crisis, according to an ACA press release.

According to GCA member and ACA spokesperson Dr. Robert Hayden, the ACA has hired the Capitol Hill Consulting Group to "add extra strength to its efforts to pass federal legislation that would grant parity to D.C.s by allowing them to perform to the fullest scope of their license in Medicare.

"This lobbying group has strong contacts within the U.S. House Ways and Means Committee, which will play a vital role in helping any pro-chiropractic Medicare legislation to gain momentum in Congress," Hayden added.

ICA Urges Caution on H.R. 7157

The International Chiropractors Association's Legislative and Medicare committees have thoughtfully reviewed the recently introduced H.R. 7157, and strongly urge caution, according to a press release on the matter.



"The proposed Medicare coverage expansion bill as written falls short of the needs of the chiropractic community and undercuts the recognition of chiropractic in federal law as a separate, distinct, drugless and non-surgical alternative form of health care," the press release states.

The framework of the current bill, according to ICA, would allow D.C.s to be compensated for all services within their scope of practice; in some states, that would include prescribing and surgery authorization. Georgia's scope of practice does not allow for these things.

ICA does not currently support the bill as written and recommends caution to the profession regarding the language in the legislation. They are in the final stages of crafting their own Medicare legislation.

After careful review and with input from GCA attorney and lobbyist Aubrey Villines, the GCA Board of Directors has joined 37 other states and the Congress of Chiropractic State Associations in signing a letter of support for H.R. 7157. GOOD





What to get in place for a successful 2019

With 2019 just beginning, it is a good time to take stock of what worked well for you in 2018 and what you want to change or improve for the new year. That being said, it is important you remember the following to make sure you start off on a good foot in regards to claims billing:

First, be sure to get copies of all insurance cards from patients. 2018 in particular saw a huge change with regards to Medicare. Medicare patients were issued new cards containing ID numbers that did not include their Social Security numbers. If you weren't already obtaining those cards, you need to make sure you do so now.

Second, make sure you are checking benefits. Whether you choose to do those online or over the phone or perhaps both, it is imperative that you check your patient's benefits instead of just assuming that they are the same as the previous year. In addition, you want to make sure that you are aware of any limitations on the policy.

Third, have your patient sign a new assignment of benefits form. This is particularly important especially if your patient has a new insurance policy or their existing policy has changed in some form or fashion. Even if it is the same insurance as they had last year, if the ID number has changed, then technically the policy is different.

Fourth, whether you are submitting your claims electronically or dropping to paper it is important to recognize that the story you're telling the insurance company is based upon the information you're supplying on the claim form. Therefore, it is important to make sure that you are completing everything accurately. The top half of the claim form as we all know is the part that explains who the patient is, the insured is, the pertinent insurance information and whether it is accident related.

First, be sure to get copies of all insurance cards from patients.

The bottom half of the claim form is the part that says what was done (CPT coding), when it was done (dates of service), who performed the services (provider NPI) and what was the reason for the services (diagnosis coding). What is most important to remember is that your claim forms need to be a direct reflection of what is listed in your documentation.

One of the easiest mistakes to make is not updating or changing the patient's diagnosis according to what is documented in the patient's records. Keep in mind that even when a patient has an exacerbation of an existing condition, the illness date will change (Box 14) even if the diagnosis remains the same.

Keeping with the topic of Box 14, Medicare specifically states that the date listed should be the date of the "initiation of the course of treatment." Which means that if your Medicare patient states that their onset date of illness is July 15, 2015 but they begin treatment with you on Jan. 2, 2019, the illness date should reflect 01/02/2019.

Insurance billing and coding can seem like quite the undertaking to the novice and even to those with more experience. But if you are organized, keep on task and continually educate yourself, those attributes will serve you well for a successful 2019.

Limbus Bone Seen in Cadavers

The limbus bone (aka vertebral edge separation) is seen in about 5 percent of cadavers. In reality, the limbus bone represents a type of Schmorl's node occurring along the very anterior aspect of the end-plate. The theory is that during adolescence the cartilaginous end-plate softens to allow for growth during the growth spurt. The softened end-plate increases the chance of the nucleus herniating through which in this case is so far anterior that it displaces the anterior corner of the vertebra from the rest of the segment.

Clinically, there may be pain for a short period at the time of development which can produce adjacent bone marrow edema on a MRI. However most limbus bones are seen in a healed state as an incidental finding with no pain or real clinical significance.

The classic spinal X-Ray finding of a limbus bone is an oblique lucency at the anterior superior corner of the vertebral body resulting in a small triangular piece of the vertebral body being slightly displaced from the rest of the segment. In the healed state the edges will be smooth and corticated differentiating from fracture. L2, L3, and L4 are the most common locations but limbus bones may occur at L1 and L5, as well. In the healed state the limbus bone does not typically alter any form of conservative care.



(Figure 1). At the superior aspect of L4 there is a smoothly corticated triangular fragment of bone slightly displaced from the remainder of the vertebral body.

From California to Canton: Daniel Turner Exchanges Fighting Career for Chiropractic


A college sports injury led Dr. Daniel Turner away from his expected career of becoming an M.D. to the path of a D.C. during his life in California.

going to different games and tournaments. I also want to travel a lot more than I currently do, so hopefully that will happen at some point."


But his fighting days may be behind the 39-year-old.
